*One (1) Male Representative for Members with Disabilities
One (1) Female Representative for Members with Disabilities*

*One (1) Male Representative for Racially Visible Members
One (1) Female Representative for Racially Visible Members*

*One (1) Male Representative for GLBT
One (1) Female Representative for GLBT*

*Two (2) or more Male Alternates; and
Two (2) or more Female Alternates
for each of the four (4) equity groups listed above.*

The Canada Employment and Immigration Union (CEIU) is hereby calling for nominations for the positions of Representative(s) and/or Alternate(s) on the CEIU National Human Rights/Race Relations (HR/RR) Committee as per CEIU By-Law 15, sub-section 15.2.1 (b).

Elections for these positions will take place at the 2019 CEIU National HR/RR Conference being held in Winnipeg, Manitoba from September 14th to 15th, 2019. Members who are nominated for a position do not need to attend the Conference.

Any member that self-identifies as a member of an equity group listed above, and who is a member in good standing with CEIU is entitled to nominate or be nominated by another member that self-identifies in the same equity group and who is also member in good standing for the position(s) of Representative or Alternate of that equity group for which they self-identify.

Each of the four (4) equity groups' Representatives and Alternates will be elected by secret ballot by the delegates in attendance at the 2019 CEIU National HR/RR Conference who have self-identified in the same equity group.

The member with the most votes will be declared the male and/or female Representative.

The election for Alternate(s) for each of the four (4) equity group will be done once the election of both the male and female representative is completed,

As per CEIU By-Law 15, sub-section 15.2.3 (i) two or more alternates are to be elected for each of the four (4) equity groups listed in By-Law 15, sub-section 15.2.1 (b).

The member with the most votes will be declared the 1st Alternate for each gender and for each specific equity group. A new vote will be held to elect the 2nd Alternate for each gender and for each specific equity group.

IF YOU HAVE NOT YET SELF-IDENTIFIED WITH CEIU

Any member who is not on the CEIU National listing of self-identified members by the deadline date of 4 p.m. (Ottawa time) on August 9th, 2019 will not be able to nominate or be nominated for any of the positions unless that member completes a [self-identification form](#).
