On 4/17/19 I received a citizen complaint from Alejandra Restrepo of [REDACTED] Claremont Street regarding the handling of a check the well-being call. Restrepo completed the complaint form stating the incident in question took place on 4/9/19 at 1350Hrs and no officer responded to her complaint. A check of the dispatch log shows no such call from that date or time, but does show an identical call from 4/10/19 at approximately the same time. The call #19-7840 matches all the facts Restrepo placed on her form.

At 1000Hrs I placed a call to Restrepo and first asked if she was sure about the date and time and if she made more than one call. She advised me she only made one call, and might be off on the date she assured me it was a Wednesday. This matches the log. I advised her I was looking into her complaint and based on the call logs officers responded and spoke with the party she was reporting and found no odor of marijuana. I then advised her of the exact times the call was logged 1405Hrs and officers were sent at 1425 and arrived at 1428 and cleared at 1436Hrs. She then advised me she was not there at that time and only going on what her father said and he didn't notice the police come or go. Restrepo asked if officers spoke with the 3rd floor which they did. She then apologized. I asked her if this satisfied her complaint and she advised me it did.

Based on call #19-7840 the responding officer [REDACTED] conducted a proper investigation based on the facts stated to dispatch and what Restrepo placed on her form. This call was handled properly and the complaint is unfounded.
