On 12/29/2016, at approximately 0900 HRS, [REDACTED] handed me a Citizen's Complaint Form which had been sent to the Central Falls PD through the United States Postal Service.

On 01/06/2017, at approximately 1400 HRS, I called Mr. Klotz and left a message on his voice mail.

On 02/09/2017, at approximately 1415 HRS, I called Mr. Klotz again and spoke with him. Mr. Klotz had received my previous call and apologized for not returning my call. He explained to me that he no longer wished to pursue a complaint against the officer. He had thought about the evening in question and realized he was partially at fault for the altercation and he could have handled things differently as well. He thanked me for calling again and reaffirmed his desire to rescind his complaint.

On 02/09/2017, at approximately 1430 HRS, I spoke with [REDACTED]. He informed me the disagreement between Mr. Klotz and himself were based with Mr. Klotz not liking the outcome of the call for service. It was apparent to [REDACTED], Mr. Klotz was trying to use the police as a scare tactic between him and his 13-year-old stepson, who clearly had a learning disability. Mr. Klotz and his stepson's wife had been arguing and this caused the stepson to get upset and "lash out". [REDACTED] said the mother and stepson were okay with how things were handled but Mr. Klotz was not and he verbally berated [REDACTED] even as [REDACTED] and [REDACTED] were clearing the scene.

On 02/09/2017, at approximately 1450 HRS, I spoke with [REDACTED]. His version of what occurred was similar to [REDACTED]. Mr. Klotz was trying to get his stepson arrested for what [REDACTED] discerned was disrespect. [REDACTED] kept telling Mr. Klotz this was not a police issue, it was a parenting issue, and Mr. Klotz did not like this answer. [REDACTED] also thought it was a parenting issue and not a police matter.

With the complaint being rescinded by Mr. Klotz and [REDACTED] and [REDACTED] statements concerning the matter, this case is closed and the charges Obedience to Rules and Regulations and Courtesy are EXONERATED.
