Facts:

On 08/28/17 I received this IA complaint which was filed on 05/15/17.

On 09/01/17 at 10:56am I called Randy Vittini [REDACTED] 92 who filed a formal complaint on 05/15/17. Mr. Vittini stated he was stopped on two occasions by the same Officer, later identified as Officer [REDACTED]. The 1st incident occurred on 04/21/17 during the evening hrs on Dexter St. Mr. Vittini states he was pulled over by Officer [REDACTED]. When he asked Officer [REDACTED] the reason for the stop his reply was a question, "was you in another vehicle?". Mr. Vittini then claims the Officer walked around the vehicle then told him he had no front registration plate (this was the case and his front plate was on the dashboard visible through the windshield). Mr. Vittini was then given a verbal warning but feels he was stopped for no real reason and it wasn't till Officer [REDACTED] walked around his vehicle when the violation and a reason for the stop was found.

The next stop was also by Officer [REDACTED] on 05/15/17 at 10:11 pm in the area of Dexter and Moore St. Mr. Vittini states he was approached again by Officer [REDACTED] while Officer [REDACTED] stayed inside the cruiser. Officer [REDACTED] told him he ran the red light and was given a ticket. Mr. Vittini states he didn't and was going to fight the ticket. He later reported to the Central Falls Police station to file a formal complaint and encountered Officer [REDACTED]. Mr. Vittini states Officer [REDACTED] refused to give him Officer [REDACTED] name and only gave him his badge number.

Findings:

Mr. Vittini was stopped twice for vehicle violations, on 04/21/17, then again on 05/15/17, 1st stop getting a verbal warning then receiving a ticket on the 2nd. Mr. Vittini states he went to court in reference to the ticket he received on the 2nd stop and was found guilty. It should be also noted that Officer [REDACTED] is no longer employed by the City of Central Falls.

The charge of Courtesy (II-7) against Off. [REDACTED] and [REDACTED] is UNFOUNDED.

The charge of Harassment (II-10) against Off. [REDACTED] is UNFOUNDED.
