Petition Circulator Instructions

(Please make copies of blank petition before circulating)

Petition circulator must:

1. Be at least 18 years old, a U.S. citizen, and may reside anywhere in USA.
2. Personally observe each person sign petition.
3. Fill in all blanks in circulatory statement after completing sheet, but do not sign your name until in the presence of a notary public.
4. Sign each petition as circulator in the presence of a notary public.

Petition signer must:

1. Be a resident and registered voter in one of the following 30 counties in the 4th District: Adams, Brown, Calhoun, Cass, Champaign, Clark, Coles, Cumberland, DeWitt, Douglas, Edgar, Ford, Greene, Jersey, Livingston, Logan, Macon, Macoupin, Mason, McLean, Menard, Morgan, Moultrie, Piatt, Pike, Sangamon, Schuyler, Scott, Vermilion, and Woodford.
2. Personally sign the petition (may not sign for a spouse).
3. Fill in his/her full physical address (no P.O. box).
