38	Sec. 2. An Act To establish and provide for the maintenance of a free public library and
39	reading room in the District of Columbia, approved June 3, 1896 (29 Stat. 244; D.C. Official
40	Code § 39-101 et seq.), is amended by adding new sections 15 through 17 to read as follows:
41	"Sec. 15. Books from Birth.
42	"(a) There is established the Books from Birth program as a program of the District of
43	Columbia Public Library ("DCPL"), to be administered by the Executive Director of DCPL.
44	"(b) The Books from Birth program shall provide books to all registered children, mailed
45	to the home residence of the child at the rate of one per month, from the month following the
46	child's birth or enrollment in the program to the child's 5th birthday.
47	"(c)(1) The Executive Director shall make reasonable efforts to register every child under
48	the age of 5 residing in the District.
49	"(2) The Executive Director shall be authorized to enter into such memoranda of
50	agreement or understanding with the Department of Health, area hospitals, or other entities as
51	necessary to ensure each family receives registration information upon the child's birth.
52	"(3) The registration list shall be used solely for activities related to the Books
53	from Birth program and shall not be sold or used for any other purpose.
54	"(d) The Executive Director may include information about library programs and
55	services, including those related to children, adult, or family literacy, or other educational or
56	literacy material as the agency deems useful with materials delivered each month.
57	"(e) The Executive Director shall choose the monthly book titles from recommendations
58	provided by the Book Selection Committee established in section 16.

62	"(a) The Executive Director shall establish a Book Selection Committee ("Committee")
63	composed of experts in early literacy for the purpose of providing recommendations of book
64	titles to be distributed for each age group.
65	"(b)(1) The Executive Director shall establish membership criteria including length and
66	terms of membership and selection process.
67	(2) Members shall serve without compensation.
68	"(c) The Executive Director shall post on the DCPL website:
