As a business owner and dedicated supporter of local, sustainable and organic foods and products as a means towards better health, a cleaner environment, and a sustainable local economy, I believe Chicago Market will connect consumers with their food production in a way that benefits both the community and our local economy. I, Andrea Hazzard and Hazzard Free Farm Grains is ready, willing and able to provide products to Chicago Market and I look forward to this opportunity to better serve my target consumers.

As a diversified farmer and miller, it is exceedingly difficult to balance time spent in food production with the need to connect to consumers through marketing to restaurants, farmers' markets, CSAs, and other forms of sales. As it accomplishes its mission, Chicago Market will expose my brand to consumers who would have never known about it otherwise and who recognize the value in the production methods of small-scale producers like me.

I fully support Chicago Market. Chicago Market is a leader in the local-food movement. I know it will greatly benefit the community while providing companies like mine an opportunity to materially grow and increase our sales.
