Subject: Temporary Detour

Locations: Martin Luther King Jr. Blvd % Crenshaw Blvd. and Central Ave.
Crenshaw Blvd. % Martin Luther King Jr. and Exposition Blvd.

Reason: Ciclavia – South LA 2021

Line: 10 (Rte. 48)

Northbound: Regular route to Main St. and Vernon Ave. then continue on Main St., R-Jefferson Blvd., L-Maple St. and regular route.

Southbound: Regular route to Maple St. and Adams St. then continue on Maple St., R-Jefferson Blvd., L-Main St. to Martin Luther King Jr. Blvd. and regular route.

Line: 40

Northbound: Regular route to Crenshaw Blvd. and 48th St. then continue on Crenshaw Blvd., R-Leimert Blvd., R-Vernon Ave., L-Broadway. to Martin Luther King Jr. Blvd. regular route.

Southbound: Regular route to Broadway and Jefferson Blvd. then continue on Broadway., R-Vernon Ave., L-Crenshaw Blvd. and regular route.

Line: 102

Eastbound: Regular route to Crenshaw Blvd. and 43rd St. continue via Crenshaw Blvd. to L- Vernon Ave., L- Western Ave. to Martin Luther King Jr. Blvd. and regular route.

Westbound: Regular route to Western Ave and Martin Luther King Jr. Blvd. continue via Western Ave. to R- Vernon Ave., R- Crenshaw Blvd. and regular route.

Line: 105

Eastbound: Regular route to Santa Rosalia Dr. and Marlton Ave. continue via Santa Rosalia Dr. to L- Stocker St., R- Crenshaw Blvd. and regular route.

Westbound: Regular route to Crenshaw Blvd. and Vernon Ave. continue via Crenshaw Blvd. to L- Stocker St., R- Santa Rosalia Dr. to Marlton Ave. and regular route.

Line: 200

Northbound: Depart temporary layover via Exposition Blvd., R- Figueroa St. and regular route.

Southbound: Regular route to Figueroa St. and Jefferson Blvd. then continue via Jefferson Blvd. to R- Flower St., R- Exposition Blvd to temporary layover between Flower St. and Figueroa St.

NOTES: Depart temporary zone 6 minutes after time point on running board for Hill/MLK via Figueroa St. and regular route. Keep engine turned off until 1 minute prior to departure.

Route to temporary layover zone/relief point Line: 200

Out: Depart Division 2 via Griffith St., R-Adams Blvd., L-Flower St., R-Exposition Blvd to temporary layover

In: Depart temporary layover zone via Exposition Blvd., R- Figueroa St., R-Adams Blvd., L-San Pedro St., R-into Division 2 yard.

Line: 210

Northbound: Regular route to Crenshaw Blvd. and 48th St. then continue on Crenshaw Blvd., R-Leimert Blvd., R- Vernon Ave., L- Western Ave., L- Exposition Blvd., R- Crenshaw Blvd. regular route.

Southbound: Regular route to Crenshaw Blvd and 36th St. continue via Crenshaw Blvd. to L- Exposition Blvd R- Western Ave., R- Vernon Ave., L- Crenshaw Blvd. and regular route.

Make passenger stops at all intersections where it is safe to do so while on detour route.

Note: Supervisors must post signs in affected areas
