#### General Manager's Report

June collections from past due assessments and transfer fees was \$19,558.17.

Clear Lake Church of Christ conducted their Impact Week and helped us plant flowers and paint the pillars around the rec facility. They also remove pine needles from the sand at Rutledge Park.

An additional week of camp was added for August 13-17<sup>th</sup> to bring in additional revenue. We are currently at a 22% increase over last year in camp revenue.



Donations for Jan-Aug:

Monument Beautification: \$89.52;

Park Beautification: \$245.75; General Donations: \$2,181.96

As of today we have three people interested in the park bench and table dedication program. Two people would like to purchase park benches and one would like to purchase a picnic table.

The Audit is continuing and we are closing in on an accurate number of accounts receivables. We are off by approximately \$30K. The office is working to find the remainder of the discrepancy. Most of the discrepancies have been past owners or accounts that were combined during the transition. Every account is being looked at and the office hopes to have a list of account balances that need to be written off due to foreclosure or sale through legal from the past 5 years.

NASA Little League is still interested in purchasing the land discussed in their proposal (the tennis courts and parking lot across the street). This will be discussed further at the facilities meeting in September and brought to the Board in September.

The gym A/C is on its last leg. This will be discussed at an upcoming facilities meeting.

# ACLC - Buffy Downing (covered for Terry Canup)

The ACLC met and discussed Hurricane Harvey and what Clear Lake City needs to do with the drainage in the area. Friendswood received most of the rain. Clear Lake received 60" of rain, the 2<sup>nd</sup> most in the area. We received 10.2" of rain in a 12-hour period. It was learned that Horsepen Bayou is not draining properly. There were 68 deaths. 300,000 structures flooded and 500,000 vehicles flooded out. There were 40,000 evacuees.

#### CLCWA – Buffy Downing

The CLCWA meeting was the 35<sup>th</sup> anniversary of Hurricane Alicia and August 25<sup>th</sup> will be the 1-year anniversary of Hurricane Harvey. Ellington Field says they cannot have wet-bottomed ponds due to issues with migratory birds. The FAA killed wet-bottomed ponds within 10,000ft of runways.



#### ARC - Leslie Eaton

The ARC met on August 14 and there were eight residential applications submitted. The applications were for three driveways, two tree removals, painting two homes, one roof replacement, a room addition, and replacing the gutters, fascia and soffit.

There was one Commercial application submitted for the installation of a promotional sign. All of the applications were approved as submitted.
