#### Treasurer Report

Treasurer Glenda Stroud gave the Treasurer's Report. We moved \$75,000 from the Operating Account to the Shell Account. Last year we transferred \$150,000, but it was less this year due to the expenditures. The expenditures include improvements and repairs (A/C, pool service, pool reinspection, asphalt maintenance, etc.), and striping the OBW pool parking lot.

We will be receiving a dividend check from Texas Mutual Insurance for \$5,242.70 because we had no Workman's Compensation claims.

The Accounts Receivable on the Balance Sheet is \$215,415.79.

We have a \$100,000 CD coming due on July 29. The rates are very low right now. We can table this until next month and when it comes due it will automatically roll into the Money Markey account. After reviewing the offer sheet, the Board decided to go with a short-term CD in hopes the rates go up.

#### General Manager's Report

The May collections were \$11,432.42 and includes transfer fees, etc. There are currently 21 active payment plans with property owners. The Accounts Receivable is \$215,415.79.

The Reserve Study was conducted by Criterium-Farrell-Yancy Engineers on 3 July 2019 and we are currently waiting on the report.



All of the unpaid assessments as of August 1 will receive a \$25 late fee.

The Lunar Landing Family Fun Run has almost 600 runners signed up plus a 1K run for kids with 40 kids signed up. It will kick off early Sunday morning.

The closing on the Friendswood Ranch Property took place on July 1, 2019. The special Warranty Donation Deed was filed with the Harris County Clerk's Office. Surveys were also sent to Silversands to add the contract for mowing and to Brady Chapman to add the property to our insurance. We also need to file for tax exemption for 2020.

The Clear Lake Church of Christ Impact Week will run July 22-26. The volunteers will beautify the CLCCA monuments along Hwy 3 as their project.

HPD is working with us to obtain 911 key boxes for quick access to our pools and facility in case of an emergency.

#### HPD PIP - Jennifer Taylor

Crime is down a bit in the area. North of Clear Lake there were over 700 Burglaries of Vehicles. HPD also is on the watch for "Juggers". These are individuals who follow people from banks, etc. and then rob them. HPD also is going to have a free VIN etching program for vehicles. Food trucks also have had a rash of robberies because they deal with cash. HPD also is accepting backpack donations for their back to school program.

There is no ACLC meeting in July.

#### **CLCWA** – Linda Coblentz

There was one speaker on the issue of the sewer backing up into people's showers in the homes in Oakbrook on Neptune and Festival. The water authority thinks it probably is from AT&T work in the area where they drilled horizontally but is going to look into it.

The water authority also passed a resolution regarding the fences along Exploration Green, formerly the golf course, giving the CLCCA the authority to change the fence restrictions for homeowners.

The Architectural Review Committee met on 9 July 2019. There were 5 residential and 2 commercial applications. Several commercial variances were submitted to the Board for approval. Hope Christian Reformed Church at 770 Pineloch submitted a request for a larger monument sign with an LED board. They are requesting an 8-foot sign to allow the extra 1 2/3 feet for the base. The sign will be placed away from the road so there is no obstruction to view for traffic. They are also willing to follow the color policies.

Linda Coblentz asked why we were giving the church a variance but not one to Bill de la Garza when he requested a variance. De la Garza's sign was significantly closer to the street that the location of the church sign.
