#### **Treasurer Report**

Treasurer Glenda Stroud gave the Treasurer's Report. As approved at the July Board meeting, the Capitol One CD that matured on 7/29/2019 was reinvested with Barclay's on July 18 for a 2% rate. The CD will mature on July 23, 2020.

The current statement balance is \$1,077,567.02.

Two additional CDs will mature in 2020: July 13, 2020 Comenity Bank for \$100,000 November 24, 2020 Ally Bank for \$100,000

## General Manager's Report

The June collections were \$13,898.44 and includes transfer fees, etc. There are currently 21 active payment plans with property owners. The Accounts Receivable is \$319,398.03.

The Reserve Study was conducted by Criterium-Farrell-Yancy Engineers on 3 July 2019 and we are currently waiting on the report. They are expected to complete the study by August 30<sup>th</sup>.

The gym boiler inspection needs to be scheduled. The General Manager contacted several commercial companies to inspect and clean the unit. Repairs needed will be an additional cost. The Board reviewed the bids to inspect and clean the gym boiler unit.

We have had a 16% increase in the number of residents using E-pay and Buildium over the past two years.

The insurance renewal forms are currently in progress.

Camp Clear Lake passed inspection on July 22<sup>nd</sup> with no issues. There was a 3% increase in camp participates this year.

There were no additional insurance premiums for obtaining the Friendswood Ranch property donations.

## HPD PIP - Jennifer Taylor

Clear Lake is still experiencing Burglaries of Vehicles and "Juggers" who follow people from banks, or from their business to the bank with a bank bag and then rob them. The burglars are from out of the area. 311 also spoke about heavy trash issues and delays. Residents are complaining that they are taking their trash out and sometimes they get missed. Residents also are putting their trash out early to avoid being missed.

### ACLC - Terry Canup

### **CLCWA** – Linda Coblentz

They have resumed spraying in ponds to suppress the mosquitoes through August & September. The CLCWA also has purchased a new computer program that interacts with the stations better.

The Architectural Review Committee met on 13 August 2019. There were 14 residential and 2 commercial applications. Three of the residential applications were disapproved. A home on Waybridge Drive wanted to replace windows but did not supply enough information. A home on Torry Pines requested a new fence, however the ARC needed more information on the fence,



including a drawing on the plot of where the fence is to be placed. A home on Cobre Valley Drive wanted to replace the rood with a green shingle, but the ARC needs to see a sample of the green shingle to assure the color is acceptable.

There was one Commercial ARC request that was approved as submitted.
