President's Report

President Terry Canup discussed the issue with the OBW fences and that the OBW homeowners do not want to be responsible for repairing the fences. The City of Houston Public Works department has advised that they do not repair or install fences along or in the right-of-way and that fence maintenance is the responsibility of the homeowner. The only action that Houston Public Works would take would be to investigate the fences and have them removed if they are deemed a hazard. It is still the responsibility of the homeowner to maintain the fence per City of Houston. The CLCCA, City of Houston, and State of Texas all agree that the homeowner must maintain the fence.

Since the company that made the fence planks has ceased to exist, it is OK for the homeowner to replace the planks using hardiplank. If the homeowner wishes to use another material, they may apply for a variance through the ARC and the Board will approve it on a case by case basis. It is in the homeowner's best interest to maintain and repair their fence.

The CLCCA Board elections are scheduled for May 2, 2020 from 7am to 7pm. Hopefully we will be out of lockdown by the election.

\$129,000 transferred in April from UBS. \$38,000 transferred in March from Shell. Hopefully, we can transfer some money back.

3 CDs mature in 2020. 2 CD's in July and one in November.

General Manager's Report

The February collections were \$13,586.39. The March collections is \$9,418.24 and includes transfer fees, etc. The Accounts Receivable is \$234,336.33.

We have 20 in-house payment plans.

The facility closed beginning on 13 March 2020 due to COVID-19.

For Tag-holders, they will receive additional days on the length of their tag membership and will not receive any refund.

For those who purchased Classes, they will receive credit towards additional classes.

The parks are currently closed.

JC Leak Detection did a great job on the indoor pool repairs.

The resurfacing of the Rutledge Park Tennis Courts is scheduled to begin the week of March 16th and is expected to take 3-4 weeks.

The Board Election is scheduled from 7AM to 7PM on March 2. Early voting will be 30 April & 01 May 2020. Absentee voting begins on 22 April 2020.

They finalized the purchase of 2 acres of land on El Camino. There is \$727 in assessment fees that we will no longer receive.

The CLCWA finalized a change in their governing documents to waive fees.

Committee Reports

ARC - Leslie Eaton

The Architectural Review Committee met on 10 March 2020. There were 9 residential and 2 commercial applications. Seven of the residential applications were approved and two were disapproved. One home requested to repaint their front door, one homes requested to add a fence, one home requested to replace the roof, add a patio cover, and patio concrete, one home requested to remove four trees, and one home requested the installation of a swim spa (hot tub) in their back



yard. One home requested to install solar panels, and one home requested to install a work shed. These residential requests were approved as submitted. Applications that were disapproved included a request for a curb cut, adding a picket fence, and a request for a shed.

There were two Commercial ARC requests. The Christ Church Assembly requested a monument sign. The sign was approved with restrictions. The Mesquite Grill requested a building sign. The request was disapproved as submitted.

Facilities Committee

The Facilities Committee met and discussed several items:

- 1. Water Slide Mats placed on hold
- 2. New shade structures for at outlying pools placed on hold
- 3. The diving boards are in very bad shape. They cost \$12,000 each. We may want to consider replacing only 1 board for now.

Rachel noted that the courtyard concrete is in bad shape and has numerous trip hazards. They are going to re-walk the facility and see what absolutely must be replaced.

The concrete floor in the indoor pool area has lost much of its non-skid surface. The last time it was painted the floor was not prepped very well.

Stan Cook noted that he would like to set up a tour/workshop for the Trustees.

Items in the men's locker room that need work include:

- 1. Tile replacement
- 2. Mats, walls, etc. need to be pressure washed and painted
- 3. Paint is peeling off of the walls
- 4. We need to repair light fixtures

Other items in need of repair:



- 1. Outdoor pool entrance way paint
- 2. Courtyard concrete repair
- 3. Fullerton Park structures
- 4. Outdoor pool repairs
