Finally the Election Committee that met on March 14th was quit unprepared for the Committee meeting where several items are still unresolved.

Reviewed Communications committee charter 404–4C.

Mr. Swerdlin informed the Communications Committee that The Policy Statement 404-4C3 should no longer be called the CLCCA E-Communicator but the CLCCA Communicator. And remove bi-annual publication on website.

Discussed <u>REVISING POLICY STATEMENT 404-4C3: To Complete format and publishing functions of the CLCCA Communicator for distribution.</u>

Mr. Cook discussed the repetitiveness of some of the Communications Committee Policy Statement and questioned the validity of continuing to keep Communications Committee Policy Statement 404-4C3,4,5 and six. Will discuss with the By-laws Committee.

Discussed revisions for CLCCA Communicator: removal of full page and half page ads as well as a price increase for advertisement policy for CLCCA Communicator for next year 2017. Will present to By-laws Committee.

Mr. Swerdlin made a suggestion to change wording in Policy Statement 410-4B4; add "political" Policy Statement 410-4B9 "For multiple month ads, the payment must be received in as a single payment".

Discussed removing Policy Statement 410-4B13 in its entirety.

Discussed bringing back CLCCA Sail Boat Logo and adding "since 1963" under the wording "Community Association Inc" on the Sail Boat Logo.

Motion was made by Mr. Cook to discuss The Yard of The Month winners. Mrs. Slade seconded the motion. Mrs. Morales requested to present and include BOT to recommend candidates for Yard of The Month. Mrs. Morales also suggested getting Yard of The Month signs made so that they can be displayed in the winners' yard.

Mrs. Slade requested to modify the original motion of Yard of the Month to Yard of The Quarter.
