Even if no quorum was reached and discussions were held to review the material on the agenda, that information should be listed in the minutes, even though no consensus could be reached without a quorum. Bylaws 6.4, 6.6, 7.9, 7.11, 7.12, Policy 401-2 & BOC 22.219 deal with Standing Committee and its responsibilities. Finally, members of the Communication Committee should review the website and identify the hyperlinks that do not work and inform staff to get them fixed.
