Ana Medlin resigned four days before the Fall Festival. Rachel and Monique teamed up to finish organizing it. The November 5, 2016 event was one of our most successful Fall Festivals we have held. There were 22 vendors. Vendor revenue totaled \$1,210.00 and the entry and concessions income was \$428. The net revenue was \$704.83.

HPD PIP – Leslie Eaton

The HPD PIP meeting discussed recommendations to keep homes safe including keeping house doors and garage door locked, even when you are not home. In addition, keep vehicles locked when they are parked in your garage, even if the garage door is locked.
