Treasurer Report - Glenda Stroud

Treasurer Glenda Stroud reviewed the financials and presented the offer sheet for the upcoming CD renewals. She indicated that we are below our \$1 million restricted reserves due to capital expenditures and low rate of return on the CDs. She also indicated that we do not have to make a decision until March 27, 2017. She also explained that we "owe" \$52,807.72 to Operations, and we moved \$40,100 from UBS to Operations. Lastly, Glenda indicated she made an error last month on the checklist: Prosperity Bank should be listed as Bank of America.
