## Treasurer Report - Glenda Stroud

We have a balance of \$109,300.89 in the Bank of America account for the insurance proceeds. On February 28 we transferred \$6611.84.

The UBS Reserves is \$1,080,453.82. The Treasurer added the Tracking the Value of Your Account graphics to the Treasurer's Report. The next CD is due on 6/25/2018 for \$100,000.

There were no transfers this month and there is \$46,422.34 remaining in the Shell Credit Union account. We had a \$5000 deposit from the insurance payment for the pool boiler.

# General Manager's Report

The Pavillion and C/D rooms are nearly complete. Janet has collected \$16,486.05 this past month from past due assessments and other fees.



The annual Easter Egg Hunt is scheduled for March 24<sup>th</sup>. Robyn, the new Recreation Director, secured several vendors and the event will include a petting zoo, an obstacle course, and an activity table for the children.

Robyn also is working on the advertising for the summer camp. CCISD has started their flyer distribution again and will be advertising to a few schools outside our area again. We hope to increase our attendance numbers this year.

The Clear Lake Stars have requested to rent the Kreuger Park pool again this year, however the pool motor is in need of replacement. Quotes are currently being requested for presentation to the Facilities Committee.

It is time to start working on the April Newsletter. Please email the General Manager with items no later than March 28<sup>th</sup>.

Buildium has been much more time consuming that we were told it would be. We are asking for a reduced rate because of the additional time to input data into the system.

There are several plumbing issues at the Rutledge Park pool after the last freeze. Mike's Plumbing repaired numerous items that were damaged. They also discovered an issue when the toilets were flushed. Their camera would not go down the pipe. Roto Rooter came out with their jet machine and they were able to clear the pipe to 230-140 feet. Additional clean outs need to be installed to clear the issue. Quotes will be obtained and presented to the facilities committee.

## **HPD PIP – Linda Coblentz**

The crime rate is down in the Clear Lake area.

There will be a Town Hall meeting April 12 at the Clear Lake Methodist Church. They will have helicopters.

There will be a BOPA pickup on Saturday. This is for Batteries, Oil, Paint, and Antifreeze.
