KNOW ALL MEN BY THESE PRESENTS:

THAT WHEREAS, Friendswood Development Company, as Declarant and owner of the land platted into that certain subdivision known as Meadowgreen, Section Three, caused to be executed and filed of record that certain instrument entitled Declaration of Covenants, Conditions and Restrictions for Meadowgreen, Section Three, a Subdivision in Harris County, Texas, recorded under County Clerk's File No. K010384 on May 8, 1985, Film Code Number 014-69-1919 et seq., and amended by instrument entitled "First Amendment to Declaration" dated July 23, 1985, recorded on August 2, 1985 under County Clerk's File No. K137843, Film Code Number 022-62-2119 et seq., and further amended by instrument entitled "Second Amendment to Declaration" dated September 27, 1985, recorded on October 1, 1985 under County Clerk's File No. K227765, Film Code Number 027-72-1643 et seq., in the Official Public Records of Real Property of Harris County, Texas (hereinafter sometimes referred to collectively as "the Declaration"), which instruments established and imposed certain conditions, covenants and restrictions upon the properties described therein;

WHEREAS, Article IV, Section 1 of the Declaration provides that the Declaration may be amended by an instrument signed by a majority of the owners of the lots; and

WHEREAS, it is the desire of the undersigned, being the majority of the owners of the lots, representing not less than fifty-one percent (51%) of the total ownership of the lots in the Meadowgreen, Section Three subdivision, to supplement and amend said Declaration by execution of this Supplemental Amendment.

NOW, THEREFORE, the undersigned, being the President and Secretary of Clear Lake City Community Association, Inc., and those owners representing the majority of the lots, whose signatures are attached hereto as Exhibit "A" and incorporated herein by reference for all purposes, hereby agree to supplement and amend the Declaration by adding the following new paragraph:

The following paragraph is added to Article III of the Declaration:

"All lots shall be subject to a mandatory AUXILIARY RESIDENTIAL COMMUNITY SERVICE CHARGE in addition to the Community Services Charge, as referenced in Article III. This charge is intended to supplement the Community Services Charge and provide funds for the common general fund of Clear Lake City Community Association. The Auxiliary Charge shall commence on July 1, 2011, and be charged each year thereafter, along with and in addition to the regular Community Services Charge. The initial rate of the Auxiliary Charge

is established at \$80.00 per lot, per year, to be billed along with the Community Services Charge in the same manner, and subject to the same late fees and penalties as the Community Services Charge. Such fee may be increased annually by the Board of Trustees (there shall be no requirement for such increase) no more than three-percent (3%) above the previous year. If the Board of Trustees does not increase in a given year, such amount may not be combined with nor carried forward to a subsequent year."

WE, THE UNDERSIGNED lot owners hereby adopt the foregoing Supplemental Amendment to Declaration of Covenants, Conditions and Restrictions for Meadowgreen, Section Three, a Subdivision in Harris County, Texas.

The supplemental amendment to the Declaration set forth above shall be deemed to be a part of and shall be interpreted in accordance with the Declaration. All provisions of the Declaration not amended herein are hereby ratified and confirmed in all respects.
