

APPENDIX A - City Inventory of Programs and Services for Older Adults - July 2018

DEPARTMENT OF AGING (LADOA) - SUPPORTIVE SERVICES PROGRAM

LADOA administers the **Supportive Services Program** which is designed to enable older adults to address functional limitations, maintain health and independence, protect elder rights, and promote access. Examples of specific services include the following.

- **Legal Services** increase the availability of legal assistance to older adults age 60+. Types of legal services include: (1) public entitlement law (e.g., disability benefits); (2) housing-related law; and (3) institutionalized advocacy.
- **Personal Care** services include assistance, supervision, or cues w/ activities such as eating, bathing, walking, grooming, transferring in/out of bed/chair.
- **Homemaker** services include assistance with preparing meals, shopping for personal and household items, managing money, using the telephone or doing light housework.
- **Chore** services include assistance with heavy housework, yard work, and other home maintenance.
- **Case Management** is designed to provide access to needed services and includes activities such as needs assessments, development of care plans, coordinating services, and providing follow-up.
- **Information and Assistance** includes: (1) dissemination of information about resources; (2) linking older adults to available resources; (3) to the extent possible, following up with individuals.
- **Outreach** includes interventions (one-on-one) contacts with individuals initiated by an agency or service-provider for the purpose of identifying potential clients.

Together, these services are intended to help older adults maintain the highest possible levels of function, participation, and dignity in the community.
