



For follow-up: Check Monday 10/17 for Toscano time. He texted on 10/17 @ 1254 hrs that he was going to be late and he was the only one scheduled to work that night. I texted back, "how late?" And he then texted "6-630". I texted back-"ok I'll see if someone can cover till then". He texted back a "smiley face" with a love heart on the edge of it.

I asked Sgt. Simonson to stay until Toscano could make it in, and Sgt. Simonson agreed to cover. Toscano did not say why he was going to be late and I did not text or call him back to find out because I myself was busy. With the short staffing in the unit and only a single person often covering the night shift, this is an occasional occurrence for the unit. The unit currently has two people out of service; one on days, and one on nights.

At 1959 hours when I was off-duty, I received a text from Sgt. Simonson to call him. I phoned him and learned that Sgt. Toscano had still not shown up for work. Sgt. Simonson said he had called Toscano to find out his ETA and Sgt. Simonson learned that Toscano was working an off-duty job for the filming of a movie and it was running longer than expected. Sgt. Simonson said he could continue to cover the shift. I told Sgt. Simonson to stay and continue to work and keep the unit open. I told him that if Toscano had not shown up by midnight, that Simonson should leave because he was scheduled for training the next day at 0800 hours and I wanted him to be rested for that shift. Sgt. Simonson put in an OT slip until midnight.

Sgt. Toscano was scheduled to work Tue 10/18, and I intended to try to meet with him to discuss his calling in late. I also intended to ask him if he ever came into work because when I checked the schedule on Tue morning 10/18, I noted that Monday 10/17 was still showing that he had Reg hours 1600-0200. I do not know if Sgt. Toscano ever showed up for work at all on Monday 10/17. I ended up having to

leave for a medical appointment earlier on Tue than Toscano's scheduled time to work so I was unable to meet with him to discuss the Monday work schedule matter.

Today (Wed 10/19) when I came in I noted that Toscano put in or had put in a vacation day on the schedule for Tue 10/18. So I would not have been able to talk to him anyway. I also note that Monday 10/17 is currently left unchanged from the scheduled regular work day 1600-0200. I am awaiting his time entry for that shift. He now has a string of days off and vacation days strung together so that his next shift back at work is Wednesday 10/26, when he is scheduled for an inservice training day @ 0800-1600 hours and then the schedule shows regular time (2 Hrs) after that for the remainder of the shift. His next full day back to the Juvenile Investigations office is Thursday 10/27. He then has more days off and it is the end of the payroll period and time submission is due.

Screen shot below of schedule as it appears the morning of 10/18/16.



35W Bridge Collapse Awards

On August 1st 2007 at 6:05 PM the first 911 call was received regarding the 35W Bridge collapse. The 35W Bridge was 1900 feet long and handled 140,000 vehicles on an average day. At the time of the collapse 180 people and 120 vehicles were on the bridge deck, this tragic event resulted in 13 deaths and 100's of injuries.

- The first emergency units were on the scene almost immediately.
- Within the first 2 hours 505 911 calls had been received. By 7:55 PM all of the survivors had been rescued from the scene.
- Within 3 hours of the collapse, the Family assistance center was set up at a local hotel.

Nearly 100 different agencies Police and Fire both local and federal responded, including the Park, U of M and St. Paul Police Departments.

The decision to create this year's special category of awards came about after weeks of watching the brave and tireless response of all those involved.

The criteria for these "Bridge Awards" were developed by the MPD Awards Committee after receiving submissions from individual's supervisors and peers. The submissions were reviewed and voted on by the Awards Committee.

Each of our awardees has a compelling story of their own of their part in the rescue and recovery efforts. Tonight, we would like to take this opportunity to recognize this group of officers and non-sworn staff.

We will be presenting regular department awards including Merits, Commendations, Medals of Valor and Medals of Honor. In addition, an Appreciation Award (Bridge Plaque) has been created for non sworn staff or non MPD law enforcement personnel to acknowledge there contribution to the bridge collapse.

<u>Medal of Valor</u> - is awarded to those who risked their lives at the site, who made personal sacrifices, faced possible death or serious injury to help victims of the bridge collapse. Officers, who, without thought for their own personal safety, searched for and rescued survivors from the devastation and debris on the still moving wreckage of the bridge deck.

CRITERIA FOR AWARDS

Medal Of Honor: The Medal of Honor may be awarded to a member of the department for an act of outstanding bravery or heroism. Such an act would be characterized by demonstrated unselfishness; courage, the imediate high risk of death or serious physical Injury. The award may also be posthumously given to a member who has died white involved in action of demonstrated heroism.

Medal Of Valor: The Medal of Valor may be awarded to a member of the department for an act of bravery which demonstrates obvious self sacrifice in the face of death or serious physical injury.

Medal Of Commendation: The Medal of Commendation may be awarded to a member of the department for an outstanding police act which brings credit to the department, and is highly recognized by other officers or citizens. This act is characterized by obvious self sacrifice while in the face of personal danger.

Department Award Of Merit: The Department Award of Merit may be awarded to any member of the department for an outstanding act or achievement which brings credit to the department and which involves performance above and beyond that required by the employee's basic work assignment or exceptional professional skill and conduct during a coordinated unit action.

Unit Citation Award: The Unit Citation Award may be awarded to a precinct, unit, or division, at the discretion of the Chief of Police for exemplary service or a specific action.

Chief's Award Of Merit: The Chief's Award of Merit may be presented to a department member for performance resulting In improved operations, outstanding community service, or substantial savings in organizational costs.
