**The Bikemobile is a traveling bike repair and education van that increased bike ridership and lowers carbon emissions by making simple repairs and engaging young people in hands-on demonstrations that teach them to maintain their own bikes. In 2014, the BikeMobile repaired 3000 bicycles at 120 sites.**

**Our safety program increased safe bicycling through safe routes to school drive-your-bike PE instruction for middle school students and bike rodeos for elementary age participants. In 2013 our combined safety programs were held in 18 schools, providing on-road training to over 5,000 students.**
