The Bikemobile is a traveling bike repair and education van that increases bike ridership and lowers carbon emissions by making simple repairs and engaging young people in hands-on demonstrations that teach them to maintain their own bikes. In 2014, the BikeMobile repaired 3000 bicycles at 120 sites.

Our safety program increased safe bicycling through safe routes to school drive-your-bike PE instruction for middle school students and bike rodeos for elementary age participants. In 2013 our combined safety programs were held in 18 schools, providing on-road training to over 5,000 students.

Oakland UpCycle connects over 200 low-income East Bay adults with free bicycles each year. Participants get everything they need to start using the bicycle as their primary mode of transportation—a lock, helmet, rack, and other essentials, a personalized transportation plan, and urban safety regulations training from our UpCycle instructors, who are seasoned Bicycle commuters.
