The Bikemobile is a traveling bike repair and education van that increased bike ridership and lowers carbon emissions by making simple repairs and engaging young people in hands-on demonstrations that teach them to maintain their own bikes.In 2013, the BikeMobile repaired 3560 bicycles at 118 sites

Our safety program increased safe bicycling through safe routes to school drive-your-bike PE instruction for middle school students and bike rodeos for elementary age participants. In 2013 our combined safety programs were held in 18 schools, providing on-road training to over 5,000 students.

The Bikery is the Cycles of Change collectively run, not-for-profit community bike shop in Oakland! We are committed to making bikes accessible to everybody. We offer a range of affordable used bikes for sale, repairs, classes, and community events. We also have a repair space where you can sign up and use tools to work on your own bike, and an earn-a-bike program for youth 19 and under! In 2013 the Bikery supported 1000 regular bike commuters with free or low cost services and education, and provided free bicycles to 40 youth under age 18.
