Discretionary Funds Security Grant Application*

Guidelines and Requirements

Purpose of the Fund: Given the unfortunate rise in violent attacks in communal settings it is imperative that each institution be as prepared as possible to prevent injury and harm to attendees. For this reason Councilmember Ryu is making security grants of up to \$3000 for security infrastructure hardening. Organizations that are at high risk of attack due to religious, ethnic, cultural beliefs and LGBTQ groups will be eligible for these grants. This is an invitation-only application process for institutions with a physical address in Council District 4.

What can be funded? Specific infrastructure hardening security needs at your institution that will help shore up any physical security gaps and shortfalls and or current systems that need upgrades that will make the institution safer for people attending communal services and events. The grants may also be eligible for crisis response training for staff and membership and other security training needs should this make the core infrastructure hardening improvements stronger.
