

## GLOSSARY:

**Recently Determined Cases:** Cases that have had Letters of Determination (LODs) recently issued and are within the appeal period. We will update this as we know.

**Cases Under Advisement:** Case which have had at least 1 public hearing and which are either waiting on LODs, or additional actions. Some of these cases might be keeping the record open until Neighborhood Councils meet again. However you will want to check in with the Staff Planner at [City Planning](#) who is in charge of the case to know for sure. At this time we don't know all the planners assigned to the cases but we are prioritizing making that information available.

**Cases with Cancelled Hearings:** Cases that were going to hearing in March and which have been cancelled. These cases will need to be rescheduled.

**Open Cases (Hearings required):** Cases that **can't** be decided without public hearings. Disclaimer that there are over 100 different case types in the City system and our spreadsheet represents this information to **the best of our knowledge**. All information regarding specific cases should be independently verified with [City Planning](#) as we double check our list.

**Open Cases (Hearings not required):** Cases that **can** be decided without public hearings.
