

Councilman White and the GOP Pay to Play Timeline

Councilman Dave White has voted to award at least \$5 million in contracts to numerous entities that have contributed nearly \$30,000 to his campaigns and \$159,000 to the Delaware County Republican Finance Committee.

Here are a few examples:

In May 2016, Councilman White received a \$1,000 contribution from Patrick Larkin, the Pennsylvania Area President of Insurance and Risk Management of Arthur J. Gallagher Risk Management Services, just four months after voting to approve a \$167K contract with AJG. In Oct. 2016, Councilman White received a \$1,000 contribution from the CEO of McCormick Taylor less than a month after voting to approve a \$42K contract. In Apr. 2015, Councilman White received a \$400 contribution from the President of Traffic Planning and Design, just one month prior to voting to award the company with a contract worth nearly \$263K. In Sept. 2013, Councilman White received a \$300 contribution from Mingis, Gutowski & Co. and subsequently voted to award the company with an \$86K contract the following month. In Mar. 2015, Councilman White received a \$200 contribution from an executive of Capitol Strategies Group just two months after the company received an \$86K contract. In Apr. 2016, Councilman White received a \$200 contribution from MTS' VP of Sales just 19 days prior to voting to approve a \$45K contract.

Councilman White has also taken campaign contributions from five county solicitors, including County Solicitor Michael Maddren, who pulls in nearly \$150K in salary annually from the county.

There are many more examples outlined below demonstrating that Republicans and Dave White have been engaging in a massive pay-to-play scheme for years. Insufficient transparency regulations and weak ethics requirements have made it possible for Dave White and the Republican Party of Delaware County to line the pockets of their contributors with taxpayer dollars.
