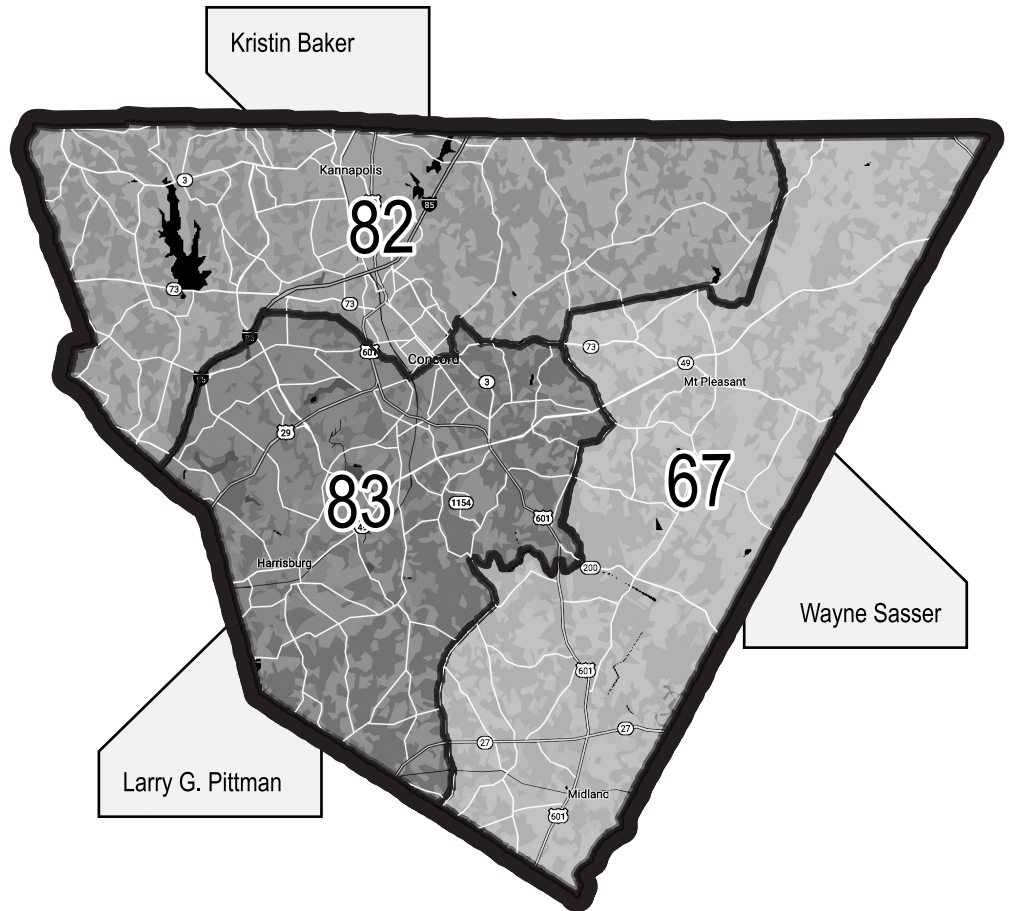

**ELECTION SCHEDULE**

September 4th	Mailing of absentee ballots begins
October 9th	Voter registration deadline
October 15th	One-stop early voting begins
October 27th	Absentee-by-mail ballot request deadline
October 28th	Last day to apply for an absentee ballot for voters who expect to be unable to vote on election day due to sickness or physical disability
October 31st	End of early voting for 2020 general election
<b>November 3rd</b>	<b>Election Day</b> Last day for BOE to receive hand delivered Absentee Ballots 5 pm Absentee-by-mail ballots must be postmarked by November 3 and received no later than the 3rd day following the general election (November 6)
November 13th	Certification of election
