### **Government and the Public Good**

1. Of all the issues confronting city government, which single issue is most important to you and why? What would you do about it if elected? *Please limit your answer to 200 words.*

There are many cases of young girls in middle school that are forced to join sex rings which are led by individuals that their immigrant status is questionable.***

***Yet, at the same time I believe that the role that ICE has taken under this current administration is a despicable one. Therefore, any collaboration that allows their sole presence in our community should be avoided until they change their ways on how to proceed in our community.***
