1. Of all the issues confronting the State of North Carolina which single issue is most important to you and why? What would you do about it if you are elected?

Expanding the Medicaid Plan. Lobby to ensure legislative victory. Every North Carolina resident should have health insurance. Medicaid will pay 100% of all medical cost. Everyone that works pays into Medicare. Money coming back to the State thru the Federal Revenue Sharing Plan is not a handout. This money must be used to ensure health care benefits for children, woman, and our elderly. People can keep the coverage they have if they wish. But those without health care can be covered. This approach will save money because we will eliminate forced hardship payments when people go to the hospital emergency services without coverage.

2. What changes would you make to North Carolina's election and campaign finance laws and why?

I would disallow dark money and establish a maximum that can be spent on a single campaign. At present, 92% of the time candidates with the most money win their elections. This approach does not ensure that we are getting the best candidates. This ensures that money is the over riding factor.

- 4. Do State Agencies have the authority they need to protect the State's natural resources from sources of pollution such as GenX, Coal Ash, Fracking, and Hog Waste? What changes would you make if any?

No. We need to institute regulations to control the pollution. GenX and Coal Ash are serious health hazards. Fracking causes the release of methane gas that contributes to global warming. Hog waste causes air pollution and devalues real property in communities. The EPA should be petitioned, and independent environmental groups take an active public position to bring attention to these issues. The Department of Health and Human Services should be challenged on these issues as well.

Never. There are no circumstances for such an exemption.

I support the Green New Deal.

7. What measures, if any do you believe are necessary to improve public education in North Carolina? In your answer please address teacher qualifications, compensation, and retention; the role of charter schools and vouchers; re-segregation; and takeover of struggling schools?

Public educational funding has too start at a 50% increase from the present budget allocation. You can only attract quality teachers by offering competitive commensurate professional salaries. Our problem in North Carolina goes back to 1954, Brown verses the Board of Education. Thomas Pearsall, Speaker of the North Carolina House kicked the can down the road with the Pearsall Plan. North Carolina never honored the Court's decision. Funding public education is constitutionally mandated. Private schools, charter schools, voucher programs, Patriot schools, Home schooling and school choice are parental decisions not public decision. A parent may choose one of these alternatives, but the parent should be ready to pay for their choice. The philosophy that the money follows the child is suspect when it affects the ability of a community to support public education. Because North Carolina has refused to integrate the schools and they have allowed 100 counties to determine what is best for their districts, you now have 100 different approaches. The late great Dr Julius Chambers, our foremost Civil Rights Attorney, sued the State of North Carolina multiple times regarding this same problem. I believe we need another challenge that will rise to the level of Brown.

8. Are you satisfied with the current system of providing healthcare to North Carolina residents?

No. Please review answer number 1. However, healthcare cost must be revisited. Services cannot be based on how much insurance you have. Managed care is simply a way of not fully treating the uninsured. North Carolina needs a hybrid plan. Expand Medicaid for those with no coverage. Allow those who have coverage to keep their plan if they would like. non-qualifiers can purchase minimum pay plans by using the marketplace and opening the door so that insurance can be purchased across state lines.

9. Is the current system of state and local taxation and fees fair and adequate to meet the needs of North Carolina residents? What changes should be made, if any?

No. North Carolina needs tax reform that will benefit everyone. Taxing should be progressive not regressive. North Carolina needs to re-instate bracketing and establish a marginal tax rate. Corporations must be taxed. At present corporations are not taxed. The constitutional change approved via referendum only served to reduce taxes for the wealthy. Thus far in North Carolina the concept of trickle down benefits created by lowering taxes on businesses has not resulted in higher wage growth for working class people. When you look at lower wages and the cost associated with earning a minimum salary, such as housing transportation indexes,

changes in any tax rate significantly impacts the overall budget and limits the amount of money available for necessary governmental programs.

I am against supporting private businesses with public funding. This has been tried before with little upside.

Yes. LGBTQ community is constitutionally protected. Discrimination of any kind is illegal and immoral. Any legislation that benefits a small group of people, like the upper 3% of wealth earners, or attacks cultural groups of people such as LGBTQ, African Americans, Asians, Muslims, or others or takes away opportunity from people with no real overriding value to society is bad legislation. I always draw on my past experiences. I grew up during the Civil Rights era. Community organization founded in non-violent protest is effective when necessary. Please remember I am an African American male experienced in the struggle.

Institute a contract bid program that accounts for the present imbalance in assigned state vendor contracts. Limit collective bids in certain areas to North Carolina state residents and businesses.
