I have done work for clients regardless of whether they paid me or not. I never sued a client to recoup payment. I have done things. I have helped people that were on the court appointed long after their case was concluded. Helping them get their license restored is one act that I can remember.

Concerning law and policy:

7. North Carolina incarcerates an extraordinary number of people, including persons convicted of non-violent crimes. Those who are incarcerated are disproportionately people of color. What if anything should the legislature and our courts do to address the issues of mass incarceration and racial bias in the administration of justice?

The legislature should not incarcerate people because they can not afford fines and or fees. For nonviolent cases bond should be waived.

8. Should the North Carolina General Assembly abolish the death penalty?

I believe the death penalty should be abolished. We are constantly finding people, with the help of modern technology, who were innocent all along. If the death penalty had been imposed on any of these people, they would have been unnecessarily killed.

9. What, if anything, should be done to improve access to justice for people with limited financial means or who mistrust the system? How should courts handle requests to waive court costs, fines, failure to appear fees, probation supervision fees and attorney's fees in criminal court, prayers for judgment continued, and similar requests?

There should greater awareness made of the fact that if you can not afford to file paperwork (for instance expunctions) that there is a process to allow the indigent to not pay fees. I think the judge should have

unlimited discretion to waive court cost, fines fees, probation supervision fees and use whatever tools are available to that judge to help people.

10. What is your position on bail? What, if any, changes need to be made to the current bond schedule?
Bail should be waived in nonviolent cases.

11. What can be done to improve language access for parties, victims, and witnesses during court proceedings?

There should be more funding to these services so that one interpreter doesn't have to cover the entire courthouse and first appearance.

12. Do courts have the authority to shorten prison sentences and release prisoners in the interests of justice and in response to emergencies like the current pandemic?

I think the current process is that lawyer file motions and work with the DA's Office and then bring the person back in front of a Judge to be resentenced and released.

13. What does racial equity mean to you and how will racial equity inform your work as a superior court judge? Have you any special training in issues related to racial disparities and equities?

Racial equity means to me that regardless of the race people, in similar circumstances, that they are treated the same. People of color have been sentenced more harshly than European people. As a Judge in Superior or District Court I would work to make sure all get a fair sentence.

I took a CLE on racial equity that went in depth on why there is racial inequity. The CLE went back to the beginning of slavery and iniquity through modern day.

14. What are your thoughts on Durham's current diversion programs? If you believe these programs should be changed in any way please describe how and why.

I think some of the diversion programs in Durham are under used especially Drug Court. I think attorneys prosecutors and Judges should look at ways to help more people to get into Drug Court as opposed to just sentencing. I think there should be a Mental Health Court. However, these Courts would need more funding.

15. What population, if any, is currently underserved, and what remedies can be implemented?

I believe people with mental health issues are a hugely underserved. The jail should not be used to as a mental holding area. The community needs better places to help those with mental health issues. For those who do enter the criminal system we need a court designed to deal with their specific issues.

16. What should the court do when both the defense and prosecution agree upon a bond request or agree on a lawful plea?

If all sides agree then I think the Judge strongly consider granting the bond request or plea. If the plea is lawful and agreed upon then I believe the Judge should grant that request.
