 - B. **Discussion and possible action** regarding passage of Measure D on the May 21, 2013 Citywide ballot, and requests by local parent groups for LAPD to shut down all marijuana dispensaries in East Hollywood. Possible action includes lobbying city council members and the U.S. Attorney's office.
 - C. **Discussion** regarding combining East Hollywood NC Public Safety Committee with a similar committee of the Hollywood Studio District Neighborhood Council.
 - D. **Discussion and possible action** regarding sending a letter to the LA Department of Transportation requesting expanded parking restrictions around the future site of La Mirada Park, located at Serrano Ave. and La Mirada Ave. Letter would request daytime "loading/unloading only" zone, while retaining nighttime tow-away zone.
 - E. **Discussion and possible action** regarding sending a letter of complaint to the State authority overseeing the Serrano Convalescent Home at 5400 Fountain Ave. regarding homeless individuals being permitted to sleep at night on its frontage, and neighbor complaints of resultant trash and break-ins.
