I. Action Items

1. **Presentation and discussion only** regarding The Trust for Public Land (TPL), Recreation & Parks, Council District 13, the Los Angeles Community Garden Council (LACGC), and many East Hollywood community members are working together to transform the half acre site, 1175 N. Madison Avenue, into a combined park and community garden. The front half of the lot (approximately 12,000 square feet) facing Madison Avenue will be transformed into a park by TPL. The back half of the lot (approximately 12,000 square feet) will be developed into a community garden by the LACGC. The goal of the park design is to create a beautiful space within the neighborhood and adjacent to the garden that is easy to maintain and helps build a sense of community. The park will accommodate a balance of green and play space and will include features that make it unique to the East Hollywood community. The playground will include play features selected by the community and placed toward the community garden to help draw visitors through the site. Public art will be designed with local artists and residents and may include a decorative mural and mosaics.

These art elements will reflect the adjacent community garden as well as the community's cultural diversity. TPL will host a community meeting to discuss the art elements and subsequent art production days in the coming months. Pleasant landscaping will add to the park's beautification. Trees, shrubs, and perennials will be incorporated throughout the park to maintain clear sight lines, and a screen hedge of drought-tolerant trees and shrubs will green the perimeter of the site along the walls and adjacent apartment complexes. To combat concerns about safety in the park, decorative fencing and community art in the entrance area will be used to deter drinking, drug use, and other illicit activities. This fence, located along Madison Avenue, will also guard children from running into the busy street. The park will have regulated hours from dawn to dusk. Security lighting and cameras will also be included at the site as is the current RAP standard.

 - Note attached Zoning Administrator's decision letter released last week on the request for a full line of alcoholic beverages and exterior dining for a proposed restaurant at 4845 Fountain Ave. The ZA restricted the hours of operation to: 8AM to 10PM Monday through Thursday; 8AM to 11PM Friday; 9AM to 11PM on Saturday; and 9AM to 10PM on Sunday. (Hours requested were 7AM to 2AM daily). The ZA permitted 16 exterior seats, as opposed to the request for 38 exterior seats. The "walk up" coffee window has hours restricted to 8AM to 9PM. The project has no condition to provide parking, as the city maintains that the site is grandfathered for none. Hours of trash collection and deliveries are permitted to be 10AM to 4PM Saturday/Sunday, and 7AM to 8PM Monday to Friday.
 - The City maintains that only the state ABC can restrict hours of alcohol sales. No other city takes this position. If neighbors wish to have further restrictions on hours of alcohol sales, they can petition the ABC.

NOTE: The Planning Entitlement Review Committee initially considered the proposed development at its January 1, 2016 regular meeting. The applicant has since eliminated his request for additional discretionary approvals of increased height and reduced open space, and is currently waiting for the City Planning Dept. to issue a Project Permit Compliance Review approval. The applicant has requested an opportunity to show the project to the Board.
