A. The Background:

There is a long history and background to this potential COVID solution. How it became politicized.

A. What is Oleandrin?

Oleandrin is an active compound extracted from *Nerium oleander*, a naturally occurring American plant. PBI's research to date suggests that the extract prevents key viruses from correctly forming their protective "envelope", rendering the virus progeny non-infective; the virus is then unable to overwhelm the host and its ability to spread itself is severely impaired. In this way, oleandrin may help "flatten the curve" and curtail the pandemic. Due to its efficacy against the viral envelope, it is considered a platform solution with widespectrum applicability to address multiple viral pathogens and their mutations.

Oleandrin has been studied extensively for decades in prestigious labs and clinical trials for cancer.

B. According to Andrew, There are Three Main Lines of the Media Attack:

- That there was somehow an "end run" around normal protocols to get to the President for a political approval. According to Andrew, this is completely false.
 - a. Phoenix Biotechnology has been following protocol since April with the FDA.
 - b. The meeting was at the suggestion of Dr. Ben Carson who is a world-renowned brain surgeon and on the COVID task force.
 - c. All they are asking is for the opportunity to be properly reviewed based on prior studies and for a fair review if further study is required.

2. That Oleandrin is dangerous, being derived from a poisonous plant.

- a. Many medicines are made from poisonous materials but refined and properly dosed.
- b. Many foods and spices (such as nutmeg) can be poisonous at extremely large doses.

- c. According to Andrew, the dosage is 1/16th the amount that would be considered dangerous to humans. To be at risk, he suggests, would require the equivalent of drinking a pint of oil (since the oleandrin is carried in oil), something no human could do. Using another analogy, it may be safe to drive at 70 mph on a Highway but certainly not safe (or possible) to drive 16x faster (1,120 mph).
- d. According to Andrew, the safety profile in the cancer clinical trials has been outstanding.
- e. The safety key is that it must be properly processed and dosed. That is true for virtually all medicines and supplements.

3. That there's no proof for this, it's just "snake oil."

- This ignores the very legitimate studies that have taken place since the 1930s.
- b. There are multiple clinical trials for various indications that demonstrate potential efficacy.
- c. In vitro lab studies and animal studies have demonstrated effectiveness against COVID, Ebola, and other envelope viruses.
- d. Even among the most critical reviews have been suggestions that this should be studied further.



- e. There is a peer-reviewed study presented for publication but the once interested publisher has now become wary due to the publicity and politicization. **ALERT**
- f. There is tremendous anecdotal evidence to suggest efficacy against COVID including a non-randomized clinical trial underway.
- g. The suggested mechanism of action is scientifically rational.

"I asked Lindell in what form he has personally taken oleandrin [00:47:00] because the FDA has not yet approved its use either as a COVID-19 drug or as a dietary supplement. It's just a liquid, like an extract, like a CBD oil. It's like an eye dropper, and you put it under your tongue,' Lindell said. Um, "Told about the alarm [00:48:00] inside the administration about how he and Carson were pushing oleandrin at the highest levels, Lindell said, 'This is the most amazing miracle thing I've ever seen in my life, so I went all-in. If you want, if you want to know what I think, I think it's being suppressed because somebody doesn't want this out there because it works, and I don't know why. Um, why wouldn't the guy that's on the task force, Carson, uh, bring the cure to the President if it's getting stopped at other places?' Lindell [00:48:30] said. 'I don't understand why they would say something like that. Basically, they'd be calling me a liar. You can't call me a liar when I've used it firsthand and have so many friends and so, and so have my friends and family.' Lindell said, 'The FDA should approve oleandrin immediately and to be sold as a dietary supplement. You can give this out as a supplement tomorrow."

testing it,' Vander Linden added. 'Given our inconclusive results and having other high-priority therapeutics to assess, we did not continue with this line of research.'"
