Humane Society International launches action against Japanese whaling company

EDO NSW is acting for Humane Society International (HSI) in their contempt of court case against Japanese whaling company Kyodo Senpaku Kaisha Ltd.

In 2008 EDO NSW acted for HSI in a long-running case that resulted in an Australian Federal Court judgement that declared Kyodo was in breach of the *Environment Protection and Biodiversity Conservation Act 1999*) (EPBC Act) by whaling in the Australian Whale Sanctuary in the Australian Antarctic Territory. The Court granted HSI an injunction to restrain Kyodo from further breaches of the EPBC Act.

Following the Court's ruling, HSI representatives travelled to Japan to serve the injunction upon Kyodo. Despite this, Kyodo has continued its whaling activities in the Australian Whale Sanctuary.

The Australian Whale Sanctuary was established in 2000 to protect all whales and dolphins in Australian waters.

With Japan's whaling program due to recommence around December 2015, HSI is now seeking to enforce the 2008 injunction. HSI applied to the Federal Court seeking orders that Kyodo is in contempt of the 2008 injunction by continuing to kill whales in the Australian Whale Sanctuary. The case will be heard in the Federal Court of Australia in November 2015.

Proposed changes to Federal environmental laws will curtail community rights

Following the Court's recent decision to set aside the Adani Carmichael coal mine approval, the Federal Government introduced legislation to repeal a key provision under the EPBC Act, limiting the ability of the community to enforce Australia's national environmental laws.

The EPBC Act is currently based on the assumption that all Australians have an interest in the health and protection of the environment and allows communities and conservation groups to act to save threatened species and protect fragile areas.

If the Bill is passed, it will limit those allowed to challenge developments that impact on the environment to those whose interests are directly affected. It would prove very difficult for communities and environmental groups to bring legal action when their only "interest" is in conserving and protecting the environment.

EDO NSW has made a submission to the Senate Environment and Communications Committee, supporting 'open standing' for any person to seek judicial review of government decisions and civil enforcement of breaches under the EPBC Act.

Volunteer program is a winner

The volunteer program at EDO NSW plays a vital role in helping EDO NSW undertake environmental law in the public interest. The EDO NSW volunteer program has the capacity to accommodate approximately 30 volunteers at one time. The requirement that law students complete Practical Legal Training (PLT) as part of their degree has increased the demand for placements at EDO NSW.

Volunteers completing their PLT requirements make a valuable contribution to the work of EDO NSW. With only a small admin team and no legal support staff, our solicitors rely on volunteers to complete work that although necessary, can be very time-consuming. Each volunteer is assigned to a solicitor who is responsible for supervising the volunteer's work over the course of their placement. This gives volunteers an opportunity become familiar with particular cases or law reform projects

For the volunteers, it is a great opportunity to undertake legal research, draft advice, collate briefs and attend court – for EDO NSW it increases the capacity of our solicitors and helps us run more cases.

Emma Vlatko recently completed her PLT at EDO NSW.

"Volunteering with Senior Solicitor, Elaine Johnson on the Carmichael Mine case gave me the opportunity to substantially contribute to one of the most significant (and highly publicised) environmental cases of the year " she said.

In addition to drafting legal correspondence and completing procedural and research tasks I was also given the opportunity to observe and take part in meetings with Counsel to discuss case strategy."

Though the case never went to trial, I could never have imagined a more enriching first experience into environmental litigation."
