Court adjourns hearing on whether Santos' Pilliga CSG facility is illegal

On Wednesday this week we were in the NSW Land and Environment Court on behalf of community group People for the Plains, who are arguing that Santos' Leewood CSG waste water facility in the Pilliga region in North-West NSW is unlawful. The group believes that the facility is unlawful because it didn't go through the proper development assessment process. They're concerned that industrial scale CSG operations are incrementally rolling out across the Pilliga region without the community having a say, and without adequate environmental assessment or safeguards.

The hearing has been adjourned until 17 and 18 May to allow the parties more time to prepare the case for the Court.

Construction company fined for failure to monitor discharge at Cockle Creek

The NSW EPA has issued a \$15,000 penalty notice to Pasminco Cockle Creek Smelter Pty Ltd for failing to monitor water discharged from its premises as required by the company's environment protection licence.

The EPA found that the operator had failed to monitor water discharged between 16 October and 21 October 2015 for metals and total suspended solids. In addition, the EPA fined the operator \$1,000 for failing to publish monitoring data on its website.

Construction and Contractor Company fined for dumping asbestos fill

Romanous Contractors Pty Ltd & Romanous Construction Pty Ltd pleaded guilty to land pollution for dumping fill known to contain asbestos into the land and watercourse bank in Mortdale. Both companies were sentenced to pay \$42,000 in penalties plus costs.

The NSW EPA has fined Biocoal Group Pty Ltd \$30,000 for failing to comply with the conditions of its environment protection licence and causing water pollution at its facility into the nearby Piles Creek in Somersby.

The NSW EPA has fined AGL Macquarie Pty Ltd \$15,000 due to a discharge of fly ash into Bayswater Creek from Bayswater Power Station. The ash was being transferred from Bayswater Power Station to Ravensworth mining complex when a pipeline partially failed.

Characterised by a very diverse flora and dominated by tussock grasses, the grasslands have declined due to clearing, weed and feral animal invasions, and changes to soil properties.
