# New case: Sydney community group fighting to protect 'brutalist' architectural heritage

Our new case is for Millers Point Community Association, who is challenging a decision by the NSW Minister for Heritage not to list the Sirius Building in Millers Point, Sydney, on the State Heritage Register.

Sirius is a public housing building owned by the NSW Government. The building is recognised internationally as a good example of 'brutalist' architecture – a 20th Century architectural style that might seem ugly to many people, but that many consider to be bold, uncompromising, truthful, functional and egalitarian.

It is an iconic building, not just as a rare example of 'brutalist' architecture, but also as a reminder of the 'green ban' movement of the 1970s led by Jack Mundey.

The NSW Heritage Council recommended that the building be listed, and the NSW Institute of Architects has called the building 'one of the most extraordinary sites on the harbour.'

## Trees remain after damage to sewer

The Land and Environment Court has dismissed an application for the removal of five trees growing on a property in Leumeah, finding that while the trees probably caused damage to a sewer in the past, this issue has already been rectified as the sewer has been repaired. The Court determined that there is no reason to remove the trees based on a hypothetical possibility that future damage may occur.

## North Wyong's Rubbish King Pty Ltd fined \$15,000

The NSW Environment Protection Authority (EPA) has fined Rubbish King Pty Ltd \$15,000 for receiving waste, including construction and demolition waste, despite being ordered to cease operations on 30 September 2016.

A prevention notice is in place against Rubbish King North Wyong, which means that the EPA may fine anyone still using their services.

# **Law Reform and Policy Watch**

## Reports of the independent Commonwealth Marine Reserves Review

EDOs of Australia has made a submission on reports released by the independent Commonwealth Marine Reserves Review. Building on our previous submissions, this submission comments on the planning and zoning proposals, policy implementation and specific impacts (climate change and mining), and makes brief comments on specific bioregions.

This is the latest stage of the Commonwealth marine bioregions review. The reports will inform the development of marine management plans.

## **Proposed Trans-Pacific Partnership Agreement**

EDOs of Australia has made a submission to the Federal Government on the proposed Trans-Pacific Partnership Agreement.

The Agreement has a chapter on the environment (chapter 20). Our submission makes recommendations on how to improve national environmental laws in

response to the proposals outlined in chapter 20. It also makes recommendations on improving access to justice, and notes the impacts that Investor-State Dispute Settlement provisions of the Agreement could have on environmental law and policy reform in Australia.

# **NSW Climate Change Policy Framework released**

The NSW Government has released a *NSW Climate Change Policy Framework*. The policy provides context for the government's approach to climate change. It sets two key objectives:

- Achieving net zero emissions by 2050.
- NSW being more resilient to a changing climate.

The government has also announced a funding package and released two draft climate change and energy savings documents for public consultation under an environmental future funding package. ## New legal opinion on climate risks and directors' duties

The Centre for Policy Development has released a new legal opinion on the extent to which Australian corporate law permits or requires company directors to take climate change into account when making decisions about company strategy, performance and risk disclosure.

The opinion has been provided by Noel Hutley SC and Sebastian Hartford-Davis on instruction from Sarah Barker and Maged Girgis of Minter Ellison Lawyers.

According the the opinion, 'it is likely to be only a matter of time before we see litigation against a director who has failed to perceive, disclose or take steps in relation to a foreseeable climate-related risk that can be demonstrated to have caused harm to a company.'

#### Australian Parliament

Civil Nuclear Transfers to India Bill 2016.

This Government Bill would regulate the export of nuclear material and nuclearrelated items, with reference to obligations under international agreements regarding nuclear safeguards.

• Aboriginal Land Rights Amendment (Local Aboriginal Land Councils) Bill 2016

This Government Bill would amend the *Aboriginal Land Rights Act 1983* to provide for the making of performance improvement orders by the New South Wales Aboriginal Land Council, and to otherwise delineate the role of the Local Aboriginal Land Councils.

Biodiversity Conservation Bill 2016

This Government Bill would repeal the *Threatened Species Conservation Act 1995*, the *Nature Conservation Trust Act 2001* and the animal and plant provisions of the *National Parks and Wildlife Act 1974* and make new provisions for the management of biodiversity in NSW.

This Government Bill would make changes to the management of Crown land of NSW.
