Port Botany company fined for maintenance issues

The NSW Environment Protection Authority (EPA) has fined Terminals Pty Ltd \$15,000 for failing to properly maintain and operate equipment for treating air emissions.

The company's Port Botany facility stores, imports, and exports large quantities of liquids including petroleum products, alcohols and oils. The EPA found that a number of components of the company's vapour emissions control system were not properly maintained or working efficiently.
