#### 6 things you need to know about Aboriginal Cultural Heritage reforms

Legal protection and management of Aboriginal cultural heritage in NSW is long overdue for reform. NSW is the only Australian jurisdiction without standalone cultural heritage legislation. Regulation continues under flora and fauna legislation via the *National Parks and Wildlife Act 1974* (NSW), at great offense to many Aboriginal people.

The NSW Government is currently consulting on the Aboriginal Cultural Heritage Bill 2018. Public comments and submissions are due by **Friday 20 April**.

The Office of Environment and Heritage is running public workshops on the Draft Bill throughout March and April, with Aboriginal facilitators (see Have Your Say in this bulletin).

### **Review of EPBC Act impacts on agriculture**

The Minister for the Environment and Energy and the Minister for Agriculture and Water jointly announced a short-term, non-statutory Independent Review focussing on the way our farmers' interact with the *Environment Protection and Biodiversity Conservation Act 1999* (*Cth*) (the EPBC Act).

A comprehensive statutory review of the Act is due later this year, and it seems this targeted review will not be a general consultation. This more specific review will be conducted by Dr Wendy Craik who will undertake targeted consultation to understand concerns of farmers and areas of potential efficiencies. It aims to identify activities that can be practically implemented in the short-term to improve regulatory clarity for farmers, in a way that does not lower environmental standards. However, it is unclear why this issue is being dealt with a sectoral review instead of as part of the statutory review, and we are also concerned about the limited consultation.

### Court and Compliance Watch

#### Pavement company fined for air pollution offence

The EPA has fined Pavements Australia Pty Ltd \$8,000 for an air pollution offence after dust from lime laying activities was blown onto neighbouring residences and cars in Hill St Port Macquarie. The EPA found that the company failed to properly assess and monitor weather conditions prior to, and during, the application of the lime and used a spreader without dust control equipment fitted.

## Law Reform and Policy Watch

### New planning policy for coastal management

[State Environmental Planning Policy \(Coastal Management\) 2018](#) (Coastal SEPP) commenced on 3 April 2018. The Coastal SEPP guides development in coastal areas, including land adjacent to beaches, estuaries, coastal lakes, coastal wetlands and littoral rainforests.

The Coastal SEPP replaces three environmental planning instruments: SEPP 14 (Coastal Wetlands), SEPP 26 (Littoral Rainforests) and SEPP 71 (Coastal Protection), including clause 5.5 of the Standard Instrument – Principal Local Environmental Plan.
