## Court and Compliance Watch

### AGL fined \$15,000 for slurry overflow

The EPA has fined AGL Macquarie Pty Ltd \$15,000 after slurry overflowed from ash dam infrastructure at the Liddell Power Station in March 2018.

A mixture of water and fly-ash overflowed across an internal road and down an embankment into a vegetated area that contains Central Hunter Box – Ironbark Woodland, classed as an Endangered Ecological Community in NSW.

### Biocoal Group fined \$30,000 for non-compliance

The EPA has issued two fines to Biocoal for contravening their environment protection licence and for inappropriate storage of waste.

An inspection in January 2018 revealed the stockpiling of residual glass fragments outside the rear of the facility, as well as additional properties being used unlawfully as waste storage facilities.

### Shoalhaven Starches fined \$15,000 for polluting incident

The EPA has fined Shoalhaven starches for discharging a diluted starch material into Abernathy's Creek. The leak was caused by a partial loss of power to an electrical control system which resulted in the overflow from the site's internal drainage system into a nearby stormwater drain.
