ETSA vegetation clearance challenge

At the initiative of the Mayor of the City of Kensington & Norwood, her Worship Mayor Vincenzina Ciccarello, a group of over 20 Councils have come together to pursue the contentious issue of the vegetation clearance provisions for non-bushfire risk areas within the *Electricity Trust of South Australia Regulations, 1988*.

The collection of Councils has decided to call itself the Local Government ETSA Regulations (Vegetation Clearance) Review Committee and the number of Councils wishing to be represented by it is steadily increasing.

ELCAS has been providing free legal advice to the Review Committee. The Management Committee considered the issue to be one of genuine public importance and hence a greater level of advice is being provided to the Review Committee by ELCAS than would normally be the case.

On behalf of the Review Committee ELCAS has written an eight page letter to the Premier of South Australia, the Honourable Lynn Arnold, asking a series of questions regarding the vegetation clearance practices of ETSA in non-bushfire risk areas. We are awaiting a reply.

Banksia Environmental Foundation

ELCAS has been nominated for the 1993 Banksia Environmental Awards in the award category group, *Metropolitan Community Groups*. The awards will be presented on June 5th, 1993.

Tax deductible status

ELCAS is obtaining voluntary assistance from Katherine Wells, a member of the Management Committee of the Victorian EDO, on obtaining tax deductible status for donations that are made to ELCAS. We are most grateful to Katherine for her assistance.

Funding

We have been actively pursuing sources of funding over the past six months. As you will recall ELCAS obtained its initial funding through donations from the SA Division of the National Environmental Law Association and the Australian Centre for Environmental Law - Adelaide (totalling \$1,000.00). That was enough to get us started but we now require access to a recurrent source of funding. In today's economic times that is not easy.

Law Foundation of South Australia application

A revised application for funding in the sum of \$3,000.00 was made to the Law Foundation. That amount of funding was sought in order to meet the immediate funding needs of ELCAS.

We are delighted to report that our application for funding was successful which means, whatever else happens, we have sufficient funds to meet our out of pocket expenses over the next 12 months.

We are extremely grateful to the Law Foundation for approving our application.

Programme of grants to voluntary conservation organisations

Maria Comino, a solicitor with the New South Wales EDO, co-ordinated an application for a particular purpose grant under the 1992-1993 programme of grants to voluntary conservation organisations to facilitate national networking between the EDO's of New South Wales, Victoria, Queensland and South Australia (ELCAS).

We are delighted that the Minister for Environment Sport and Territories, the Honourable Ros Kelly MP approved a grant for \$2,800.00 for that purpose.

We wish to thank Maria, and the New South Wales EDO for its efforts.

Approach to Commonwealth Attorney General

A tele-conference was held on 6th May 1993 between the National President of the National Environmental Law Association, John Haydon, and representatives of the EDO's of New South Wales, Victoria and Queensland and South Australia (ELCAS).

The purpose of the tele-conference was to discuss making a joint approach to the Commonwealth Attorney General for funding to be made available to each of the EDO's. The initial approach will seek annual funding for each EDO in accordance with a report prepared for the Minister for the Arts Sports and the Environment and Territories, *Supporting Community Conservation Action in Australia*, which recommended that the Attorney General's Department provide funding to EDO's in each State of Australia.

Simon Molesworth, a member of the Management Committee of the Victorian EDO, will be approaching the Commonwealth Attorney General on behalf of all of us. We thank Simon and John Haydon for their efforts. Fingers crossed!

The Advisory Service - an update
