Immigration: Legal Pride vs Illegal Insult

20th August 2006 was one of the proudest days of my life as this was the day that I became a naturalized American citizen. As I sat in the amphitheater of Congress Park in Denver, I thought back on my journey to get to this point.

For those of you who have not gone through the immigration process, I will tell you that it is nowhere near as daunting as some in the political arena would have you believe. I came here legally on a 2-year work permit; after which I applied for my Green Card. I paid the fees, experienced a rather humiliating medical exam, and had to prove that my qualifications from my home country were valid and transferrable to the United States. A few years later I applied for my citizenship. Again, this simply involved paying a fee, completing the appropriate forms, and having a rather funny interview with an Immigration Officer who had me prove that I could read, write, speak, and understand English. I found this funny because I am an English Language Major from college. The most insightful thing that I had to do as part of the citizenship process was take a civics class so that I could understand the government system and a history class so that I could understand the basis and founding elements of the United States. I was asked 100 questions of both topics – things like "Name the first 13 colonies of the United States"; something I would venture to say most high schoolers these days could not answer. I was proud that day not only to become a citizen but to finally have the right to VOTE!

All these steps seemed reasonable and appropriate for someone who wants to make the United States their permanent home. Some of you may understand my frustration and at times anger when I see thousands of illegal immigrants pouring across our Southern Border. I am the last person to be against immigration; but you MUST do it legally. There are thousands of potential immigrants in Iran, Afghanistan, China, and other countries who must wait to do things legally because they cannot walk here; and let's be honest, illegal immigrants are not crossing the Southern Border holding a college degree – not even a high school diploma in most cases.

Ah, but I hear some of you saying that I am a racist — no I am a realist. Illegal immigration does two things, it depresses the economy and wages for those at the lower spectrum of the wage scale and it allows criminals into our country and we have no way of knowing what their intentions are to American citizens. Ask yourselves this, would you be supportive of illegals living in your community if someone you loved was killed by them in a car accident because they could not read English and went down the one-way street the WRONG WAY???
