# STRIVE

A play-drive program that builds healthy relationship among peers. We'll be exploring various structured activities, arts & crafts, mindfulness practices, and sensory play while promoting physical distancing and precautions to decrease transmission of COVID-19. Participants must be registered in their age-appropriate group.

About STRIVE: A center based respite aide program, which aims to build friendships with peers through play and social activities while providing respite for families. The STRIVE program is for all children ages 3 to 17 years old.

COVID-19 remains a threat in our society. Ability4Good has taken precautions to decrease the chance of transmission of the virus within the program through complying with the recommendations of the Chief Medical Officer of Health in Alberta. As a result, families can only register to one group program (maximum 6 participants and 2 staff members), and families will be provided with Safety Relaunch Protocol of Ability4Good.

Note: Parents must provide snack for their child to bring during programming. If your child requires 1:1 attention, you must inform the Group Coordinator.

## Service Cost

The program uses aide hours issues by Family Support for Children with Disabilities (FSCD). Caregivers must confirm with their FSCD agreement and/or caseworker that they have the required aide hours. Ability4Good offers Payment Plan for families who need this option. Please contact the Group Coordinator for further information.

*Families with FSCD agreement*. This program will use 8 (2 hrs/day) direct hours and 2 (0.5 hr/day) indirect hours in the respite aide group rate of \$18.18/hr. Ability4Good will directly bill FSCD for service provided.

*No FSCD agreement.* Families without FSCD agreement will be billed \$10/hr with the activity fee totaling \$150.00.

**Activity Fee.** The activity fee is \$50.00 and is the responsibility of the primary caregiver to pay in full before the program starts.
