# **Mainstreaming: TAX**

"The EC will step up its support for gender-responsive budgeting via programmes to support public finance management. It will ensure public expenditure and financial accountability (PEFA) assessment reports include the module on gender responsiveness."

GAP2 only included support to research and independent analysis on macroeconomics and gender budgeting



Misses the point on PCD: No reference to the impact of tax avoidance and austerity on women's rights or the EU role in OECD or IMF/WB (not even under the objective of multilateral engagement)

However, public expenditure and financial accountability can justify action on tax collection



## **Mainstreaming: PRIVATE FINANCE**

"The EIP will address barriers to women's empowerment and gender mainstreaming will be applied to EU blending operation funds and guarantees.

EU action should contribute to supporting women entrepreneurship and women-led businesses, <u>including social</u> <u>entrepreneurship</u>, and their access to finance by providing innovative investments schemes through the External Investment Plan."

# Thematic Areas: Economic and social rights

The commitments on economic and social rights are more developed and stronger than in GAP 2.

BUT instrumental arguments, to a limited extent in GAP III, but prominently in officials discourses.

"Advancing gender equality could add 11 to 21 trillion euros to global GDP by 2025".

- → Women's rights need to be advanced irrespective of impact on GDP
- → Which in any cases doesn't capture unpaid care work nor environmental destruction, and is not an adequate measure of progress.



GDP IS SEXIST, Let's challenge the narrative

Women's unpaid care work is for the first time explicitly recognized as an obstacle to women's economic rights such as access to education & decent work. Universal social protection and public services are among the solutions.

#### Ten thematic objectives, among them:

Improved policy, legal framework and access to **care services** enabling equal division of domestic and care work between women and men

Increased access for women in all their diversity to **financial** services **and productive resources** 

Improved regulatory framework for ensuring equal access to universal and public quality **health care services** for women, men, girls and boys in all their diversity

**Public health systems** have sufficient and sustained financing to address the health needs of women and girls in all their diversity

Reduction in gender disparities in enrolment, progression and retention at all levels of **education**

### **Thematic Areas: The Green Transition**

"women and girls in developing countries are particularly affected by climate change and environmental degradation. As primary users of natural resources, they also play an essential role for climate change mitigation and adaptation and environmental protection. However, thy are prevented from participating equally in related governance processes."

#### Four objectives:

Increased participation of women in decision-making processes on environment and climate

Strategies on climate mitigation, adaptation, disaster risk reduction and sustainable management of natural resources and biodiversity are more gender-responsive, at all levels

Women, men, girls and boys addressing climate change in their daily lives and preserving the environment are supported

Women have improved access to jobs and entrepreneurship opportunities in the green and circular economy
