

HOW TO VOTE BY MAIL

(IT'S THIS SIMPLE!)

FIRST

Verify your voter registration eligibility here: <https://registertovoteflorida.gov>

SECOND

Request an ABSENTEE BALLOT or VOTE BY MAIL BALLOT by contacting your Supervisor of Elections. You can do this over the phone, online, by mail or in person. (There is an alphabetical list on the back of this sheet to quickly find your Supervisor of Elections contact information. They are listed by county.)

- **Online:** Go to your County Supervisor of Elections' website (check the list!) and click VOTE BY MAIL or REQUEST MAIL BALLOT.
- **In Person:** Go to your county's Supervisor of Elections' brick-and-mortar office and follow their instructions.
- **By Phone:** Call your Supervisor of Elections' office and request a ballot.
- **By Mail:** Snail mail a request to your Supervisor of Elections' office listed on the back of this sheet.

For all of these requests, you will be required to provide your name, date of birth and home address.

THIRD

Once you've filled out your ballot, you must mail it in time for it to be received at your Supervisor of Elections' main office, listed on the back of this sheet. Remember - it needs to be there by 7PM ON ELECTION DAY. But double remember, branch offices CLOSE AT 5PM on ELECTION DAY! And here are the dates:

PRIMARY ELECTION DATE: TUES, AUG 28, 2018

GENERAL ELECTION DATE: TUES, NOV 6, 2018

YEAH! GOOD JOB!

BUT WAIT!!!! BEFORE YOU SEAL IT UP AND MAIL IT IN: Check to make sure you SIGNED YOUR BALLOT! Florida Statutes requires the County Canvassing Board to REJECT AS ILLEGAL any vote by mail ballot that is NOT SIGNED. Effective January 1, 2014, Florida Statute 101.68(4)(b) allows a vote by mail voter who returned a ballot without the voter's signature to complete and submit an affidavit and a copy of his/her identification to rectify their vote by mail. The deadline to rectify a vote by mail missing the voter's signature is 5 p.m. on the day before an election.

Important reminder: Once you've filled out your Absentee Ballot, make sure you've SIGNED it, then mail it to your County Supervisor of Elections listed below.
