I, Doe Publius, declare:

- 1. I have personal knowledge of the matters set forth in this declaration, and would be able to testify competently to these facts if called as a witness.
- 2. I maintain a political blog under the alias "The Real Write Winger," https://therealwritewinger.wordpress.com/. The blog focuses on California politics, with a particular emphasis on criminal law, civil rights and liberties, and the right to keep and bear arms secured by the Second Amendment to the U.S. Constitution.
- 3. On July 5, 2016, I posted a blog entry criticizing recent legislation passed by the Legislature and signed into law by Governor Jerry Brown, which I believe violate the constitutional rights and liberties of California gun owners. More specifically, I believe the legislation, including the State's collection of personal information for ammunition purchases, infringes on the privacy and liberty interests California gun owners. A true and correct copy of the article, titled "Tyrants to be registered with California gun owners," is attached as Exhibit A to the Complaint in this action filed August 5, 2016, and a redacted version is attached as Exhibit A.
- 4. Included in the article is a list of home addresses and phone numbers of fourteen California State Senators and twenty-six California State Assembly Members. I obtained the addresses and phone numbers listed in the article through searching public records in free databases online (www.zabasearch.com), then compiled the results of the search for the post.
- 5. As the post indicates, posting the home addresses and telephone numbers was integral to my message: The point was to establish a "tyrant registration" as a protest measure against the State's efforts to compile information about gun owners. In addition to the new ammunition registry, laws that require gun owners to register rifles as assault weapons force us to not be able transfer or bequeath them, unless they are turned in or sold out of state "upon our deaths." In other words, I was trying to mimic the state's registry of citizens with assault weapons until our deaths.
- 6. On or around July 12, WordPress.com (the Internet hosting service for my blog) disabled my post and removed it from the Internet. In response to an e-mail inquiry to WordPress, I learned that the California Legislative Counsel sent a written demand to WordPress.com,

threatening to pursue a lawsuit if WordPress did not remove the post pursuant to California

Government Code section 6254.21(c). A true and correct copy of an e-mail exchange between

Plaintiff and WordPress, which includes the Legislative Counsel's takedown request, is attached as

Exhibit B.

- That, under the terms of this Section 6254.21(c), I am barred from reposting this information for four years. Cal. Gov't Code § 6254.21(c)(1)(C). I also understand that violating the statute can lead to civil and potentially criminal consequences. But for Section 6254.21(c) and the Legislative Counsel's demand (and the threat of civil and criminal statutory sanctions), I would re-post the legislators' addresses and phone numbers to my blog, and would leave such information on the Internet.
- 8. I have chosen to publish my blog under an alias and provide political commentary and criticism anonymously. I understand that this right is protected by the First Amendment. As a result of the Legislative Counsel's actions, my speech critical of the government has been censored, and the State has compromised my ability to control the content of my own message. I have now chosen to pursue this case under a pseudonym in the hopes of vindicating my First Amendment rights. I have reviewed Section 6254.21, and fear that revealing my identity may subject me to unfounded retaliatory prosecution under the criminal provisions of the statute. I also fear that the legislators I have identified, either individually or through the Legislative Counsel's Office, will further seek to further punish me and censor my protected speech by taking further action under the statute.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct. Executed December ____, 2016 in California.



To whom it may concern:

My office represents the California State Legislature. It has come to our attention that the home addresses of 14 Senators and 26 Assembly Members have been publically posted on an Internet Web site hosted by you without the permission of these elected officials. Specifically, the user on your platform by the name of "therealwritewinger" posted the home addresses of these elected officials on his or her Web site at https://therealwritewinger.wordpress.com/2016/07/05/tyrants-to-be-registered-with-gun-owners.

This letter constitutes a written demand under subdivision (c) of Section 6254.21 of the Government Code that you remove these home addresses from public display on that Web site, and to take steps to ensure that these home addresses are not reposted on that Web site, a subsidiary Web site, or any other Web site maintained or administered by WordPress.com or over which WordPress.com exercises control. Publicly displaying elected officials' home addresses on the Internet represents a grave risk to the safety of these elected officials. On the "therealwritewinger" blog site, the user describes the listed legislators as "tyrants," encourages readers to share the legislators' home addresses with other gun owners, and threatens that the home addresses will not be removed unless the legislator repeals specified gun laws or "upon the tyrant's death." The Senators and Assembly Members whose home addresses are listed on this Web site fear that the public display of t

heir addresses on the Internet will subject them to threats and acts of violence at their homes.
