Upcoming Meetings

- November
 - Procedures for Board Elections
 - How much time should candidates have to speak?
 - We would do this in addition to candidate statements submitted
 - In terms of speeches/questions: questions shouldn't be candidatespecific for the at-large candidates
 - Last time there were 4 pre-approved questions that each candidate answered one at a time
 - Decision: solicit questions to be submitted in advance, pick from those
 - Jordan will make a google form that will go out in the next newsletter
 - There is discussion back and forth as to whether there should be speaking time AND questions, or just question. We are putting it to the vote of the board
 - Option 1: No question, longer period for remarks (2 mins)
 - Option 2: 1 min for remarks, 3 questions selected from submissions
 - VOTE:
 - Option 1 passes with 8 votes
 - Constitutional Amendment
 - We believe this should be able to go to a voice vote
 - Resolution of the Redistricting Working Group
 - We can do this while the votes are being counted
 - But...who will count the votes?
 - In the past, we've appointed 2 groups of 2 people to count the votes separately
 - We can decide the day of who will count
 - Presentation from Brad Lander?
- [We don't have a December meeting]
- January
 - Panel on Budget Process and How We can Impact it
 - Proposed to pair it with an event, like a post card writing

- Erica offered for the Invest in Our New York to do a presentation on what we are focusing on: spending/transparency/advocacy
- It was raised that we need to decide on whether we are endorsing statewide candidates
 - The State Committee has its convention where members will vote on who the state committee will endorse
 - There's debate on whether our state committee reps should be deciding with the club on who to vote to endorse
- o The third Thursday of Feb is the 17th... petitioning starts on March 1st
- Reports from Committee Chairs and Working Groups
- February
 - Black History Month Speaker
 - This could also be a separate event than from our monthly meeting

Endorsements

- If we want to do a gubernatorial debate, we will most likely have to partner up with other clubs
 - We can also do this for the other statewide positions
 - UES, East Harlem, etc.*not* going south!

 - Vote: Approved unanimously
