## RESOLUTION FOR PROVINCIAL UNION PROPOSAL PLUS RELATED INFORMATION

That the C.I.E.A. Annual General Meeting approves the "Provincial Union Model" as set out in the paper and appendices of 86.01.16 (revised 86.02.08) subject to the following:

- 1. Appendix A is excluded from this resolution.
- 2. Appendix C is excluded and replaced by the "Annualized Budget for Provincial Union".
- 3. Appendix D is excluded and replaced by conditions #4, 5, and 6 below.
- 4. Regular Member dues shall be \$348 per FTE per year.
- 5. Associate Member dues shall be \$150 per FTE per year.
- 6. Dues for participation by C.I.E.A. union support staff members in the Strike/Lockout Defence Fund alone shall be \$63 per FTE per year.
- 7. Dues for Associate or Regular Membership for support staff FTEs in C.I.E.A. unions shall be at the discretion of Presidents' Council; the subsequent A.G.M. shall approve the dues level at which support staff FTEs will be continued.
- 8. Fees for service as referred to in Appendix B shall be at the discretion of the Executive Committee, subject to approval at the next P.C. meeting.
- 9. The budget which replaces Appendix C is an annualized budget; the status quo 1986-87 budget to cover the first part of the fiscal year will be voted upon separately and subsequently. The actual 1986-87 budget (a blend of the status quo and provincial union budgets) is determined by the portion of the fiscal year spent in the status quo and provincial union modes. This budget will be presented to the AGM for receipt or approval as the assembly wishes.
- 10. The provincial union dues levels will come into effect when the staff rep, legal, and defence fund services are available. The Presidents' Council shall be authorized to establish the date of transition on September 1, 1986, or as soon after as hiring and other necessary arrangements are completed.
- 11. For the months from (and including) June 1986 until the date that the provincial union dues levels come into effect, the dues levels for all C.I.E.A. members shall be \$147 per FTE per year (i.e. \$12.25 per FTE per month); thereafter dues levels shall be in accordance with #4, 5, and 6 above.
