Next month, foundations and United Ways from across the country will convene at the 2019 Funders Institute in Washington, D.C. to learn about how philanthropy can support the work to advance racial equity from the ground up to end homelessness.

During the Institute, we will:

- discuss the importance of supporting culturally-specific organizations working to end homelessness and local organizers who are fighting for affordable housing.
- have the opportunity to talk with Congressional staffers about what is most effective and helpful in understanding issues related to homelessness and housing.
- examine how foundation staff are building their grantees' capacity to learn about racial equity and shift the way they work.

Co-Sponsored Webinar: [Census Funder Debrief: Supreme Court Citizenship Question Case](#) | July 1, 4pm ET / 1pm PT

In June 2019, the US Supreme Court will issue a decision on the 2020 Census citizenship question case. No matter the outcome, funders, their partners, and grantees have more work to do to ensure a fair and accurate decennial count. Join the philanthropic community for a post-decision discussion with national organizations leading the response, including the Leadership Conference on Civil and Human Rights, NALEO Educational Fund, and Asian Americans Advancing Justice | AAJC. This meeting is hosted by the Democracy Funders Collaborative Census Subgroup, FCCP's Funders Census Initiative, and the United Philanthropy Forum.

Webinar: [Ending Homelessness Means End Urban Native Homelessness](#) | August 13, 1pm ET / 10am PT

During this webinar, we'll share how the Coalition to End Urban Native Homelessness is partnering with nonprofit and Native organizations, government agencies, tribal leaders, and philanthropic partners to drive long-term systems change. Ending urban Native homelessness requires a culturally competent, collaborative approach, and this webinar will explore how AI/Ans have historically been undercounted and under-resourced, and what funders can do to support ending urban Native homelessness.

This webinar is a continuation of the conversation Colleen will lead at our [2019 Funders Institute](#) on July 22, but this webinar is open to all private funders, United Ways, and PSOs regardless of participation in the Funders Institute.

Webinar Recording: [No Housing Support for Mixed Status Families? How Philanthropy Can Respond to the Proposed Rule](#)

In this webinar, in partnership with Grantmakers Concerned with Immigrants and Refugees, participants learned more about newly introduced [regulation](#) from the U.S Department of Housing and Urban Development (HUD) that would [force U.S. citizen children](#) and their families out of public housing if any member lacked legal status. We also examined how community-based leaders are responding, and how philanthropy can leverage its voice through comments on the regulation and grantmaking as part of the campaign against this harmful proposal.

The Workforce Innovation and Opportunity Act (WIOA) provides some important opportunities for a variety of populations that have high-barriers to employment, including people experiencing homelessness.
