- The membership is comprised of private and corporate philanthropy, representatives from the faith community as well as affiliate members from the city, county and housing authority.

# KEY STEPS IN DEVELOPMENT

## Phase One

- Moving from Managing to Solving Homelessness
- Goal: Funders receive in- depth education on the issue of homelessness
  - Convene funders' institutes and "lunch and learns" focusing on vulnerable populations, homelessness and housing solutions.
- Present information on how funders can be more strategic in their decision-making

## Phase Two

- Systems Approach to Preventing and Ending Homelessness
- Goal: Funders begin to think and act at a systems level
  - Provide systems theory education for funders, providers, community stakeholders.
  - Identify key leverage points in homeless services system for strategic investment (i.e. case management, prevention, job training/placement, conversion of transitional housing).

## Phase Three

- Philanthropy as a Catalyst for Change - Working Together at a Community Level
- Goal: Build strong cross-sector collaboration and public-private partnerships
  - Create collaborative funding opportunities by aligning resources.
  - Participate in a permanent supportive housing pilot project with both private and public funders.
  - Attend national and regional conferences on homelessness and housing.

# MISSION STATEMENT

- **Vision:** Homelessness in Houston will be rare, non-repeating and short term by the end of 2020
- **Mission:** To prevent and end homelessness in our community through actively promoting systems change and the effective alignment of resources
