New Jersey election Law requires we collect the name, address, occupation, employer and employer's address for every individual contribution in excess of \$300 in the AGGREGATE. New Jersey election law allows contributions with a limit of \$2,600 per election from individuals and corporations, except those industries regulated by the State of New Jersey. PAC's may contribute \$8,200 per election. A partnership may contribute a maximum of \$2,600 per partner per election. A letter allocating the contribution to the individual partner(s) must accompany the check. Contributions are not tax deductible for income tax purposes.
